About IVAT

Our History

In 2021, together with our team and community, we celebrated our 36th year as an Institute and the 26th anniversary of our San Diego Summit on Violence, Abuse and Trauma. The **Family Violence and Sexual Assault Institute (FVSAI)**, as we were originally known, was founded in 1984 by Robert Geffner, Ph.D., ABN, ABPP. In 1991, the Institute became a registered non-profit 501(c)3 organization to deal with family violence and sexual assault issues. It gradually expanded its scope to include child, teen, and elder maltreatment. In 1999, the Institute relocated to San Diego and, in 2006, continued its work under the name IVAT-the **Institute on Violence**, **Abuse and Trauma (IVAT)**.

To promote violence-free living by improving the quality of life for individuals on local, national and international levels by sharing and disseminating vital information, improving cross-discipline collaborations, conducting research and trainings, and providing direct professional services, program evaluation, and consulting.

San Diego International Summit

The theme of the 26th San Diego International Virtual Summit on Violence, Abuse, and Trauma Across the Lifespan – Linking Research, Practice, Advocacy and Policy, was Empowering Individuals, Families and Communities to Overcome Collective Trauma! The Summit was held August 28 – September 1, 2021 and included presentations and symposia by researchers, practitioners, advocates, policymakers, and consumers/survivors across twelve tracks concerning intimate partner violence, child maltreatment and adverse childhood experiences, human and labor trafficking, elder abuse, youth violence, services for people with disabilities, trauma in the military, sexual violence, legal and criminal justice issues, healthcare, multicultural training, services for vulnerable populations, campus



2021 marked an exciting new year for IVAT's training department launching a new On-Demand online training library, CE21. Since the pandemic pushed all training to virtual platforms, starting 3 weeks before the Hawai`i Summit and continuing through the new year, IVAT built up its online training program into a powerful, impactful resource.

3,602 people were trained in 2021 between IVAT hosted events and co-sponsored trainings. Along with holding webinars available to the public, IVAT held trainings in conjunction with several local, government, and international organizations. CEO Sandi Capuano Morrison, MA, and Director of Professional Services Morgan Shaw, PsyD, trained 182 **Hawaii Medical Service Association** staff members over 2 days on Trauma Informed Care for Healthcare Providers. President, Robert Geffner, PhD, Director of Forensic Training, Diana Avalle, PsyD, and Kelly Champion, PhD ABPP, trained 50 professionals from the **Ministry of the Interior in Dubai** over a span of 2 weeks. IVAT partnered with **VEBA**, the **San Diego Diplomacy Council, Good Shepard United AME Church, St. Mark's Church, Non-Profit Solutions**, and the **Children's Law Project of Hawaii** for additional trainings.

IVAT as a Fiscal Sponsor: Beautiful Dying Expo

IVAT continued its role as Fiscal Sponsor of the 2021 Beautiful Dying Virtual Expo, the third annual event for Beautiful Dying. Founded by Michele Little, Beautiful Dying Expo is an event created to expand awareness and encourage meaningful conversation, demystifying the process of dying and death by bringing industry experts

together to share current tools, new ideas and resources with the public. During our two-year partnership, Beautiful Dying has expanded in exciting ways, building online resources and creating a membership-oriented video library through Facebook Live called *Insights*. These videos feature topics such as Financial & Estate Planning, Advance Health Care Planning, End of Life Care, Grief Support, and more.



Peace Officer Standards and Training (POST) Grant

In 2021-2021, IVAT continued to provide training funded by the Peace Officer Standards and Training Commission (POST), a \$200,000 award. The Training, More Than Surviving: From Traumatic Stress to Wellness, is focused on officer wellness, notably after dealing with incident responses, organizational stress, and community confrontations. Due to the COVID-19 pandemic, the IVAT team was able to continue to provide training via webinar, with 172 people attending between January-April, 2021. While the work on this grant is completed, IVAT hopes to secure funding to take the training nationally.

National University Grant

In a joint effort between IVAT and National University to promote organizational wellness among law enforcement entities, a distance-learning hybrid training program was created in 2020. Funding was made possible through POST. The program incorporates the use of self-paced and synchronous learning elements for law enforcement professionals and support staff. This program is designed to help law enforcement officers (LEOs) gain the necessary tools and information to spread wellness across law enforcement, implementing self-regulation, self-awareness, and emotional intelligence into agencies to build rational thinking and approaches to wellness. Throughout the course of the grant, 400 students completed the course and the grant period ended in December 2021. IVAT hopes to use the curriculum to provide other training for law enforcement around the country.

Continuing Education & Certifications

IVAT is approved by the American Psychological Association to sponsor continuing education for psychologists (IVAT maintains responsibility for this continuing education program and its content), the California Board of Behavioral Sciences (BBS) now accepts the APA continuing education credit for license renewal for LCSWs, LMFTs, LPCCs, and LEPs, the State Bar of California to offer Minimum Continuing Legal Education for Attorneys, the California Consortium of Addiction Programs and Professionals to offer continuing education for certified alcohol and drug counselors, and the California Board of Registered Nurses to offer continuing education for nurses.

Professional Clinical & Forensic Services

IVAT continues to serve the community by providing direct services through our Professional Clinical and Forensic Services (PCFS) department. Clinically, the PCFS team provides trauma focused therapeutic services to a wide range of child, adolescent, and adult clients. We serve all clients on a sliding scale fee structure dependent on income. IVAT clinicians also support the community through partnerships with local organizations where we provide trauma-informed training to staff and clinical services to their specific clients in need. Our current partners include: the YWCA of San Diego County, the Bilateral Safety Corridor Coalition, Access, Inc., The National Conflict Resolution Center, and VEBA Resource Center.

In the forensic arena, IVAT clinicians provide trauma-informed psychological and neuropsychological evaluation with the adult criminal, juvenile, civil, and family court systems. Our team also consults regularly with legal professionals and provides expert witness testimony on a wide range of topic areas including child maltreatment, intimate partner violence, and the impact of trauma. All of our forensic work is done on a sliding scale to help serve as many individuals and families as possible.

Clinical & Forensic Training Program

Over the past year, PCFS has expanded the training program to include more clinicians and worked with several master, doctorate, and post-doctorate level students as part of its clinical and forensic training program. IVAT has ongoing partnerships with Alliant University and The Chicago School of Professional Psychology to accept students for this premier training program. IVAT also accepts students from international schools, such as the Maastricht University in the Netherlands.

Students in the program gain experience in three main areas, designed to sharpen their clinical skills, develop a solid forensic foundation, and become proficient in relevant psychological topics to train other professionals. In the clinical portion of their training in 2021, associates served almost 200 therapy clients, both in an outpatient private practice setting in the office as well as organizations in the community. Forensically, students were exposed to criminal cases locally and nationally and civil cases including personal injury and family law matters (e.g. custody).

Bilateral Safety Corridor Coalition Grant

During the second year of the grant period, IVAT continued with the Bilateral Safety Corrido Coalition (BSCC) to implement trauma-informed direct services to the clients within the program, and to streamline and strengthen parts of their programming using a trauma-informed lens. IVAT provided therapy sessions and evaluations.



Developing the Intake Process for Clients

A big accomplishment of the grant award was the collaborative work done to streamline and strengthen the initial intake and biopsychosocial procedures that all clients will encounter. A three-step intake process was better developed utilizing up to date research on appropriate, client-centered intake strategies and utilizing a trauma-informed lens.

Training on a Trauma-Informed Approach

Training was conducted for BSCC staff to increase their understanding and use of trauma-informed care. IVAT continues to work with BSCC to develop the process for comprehensive program evaluation, which will include tracking demographics and victimology data, progress in treatment and programming, and specific assessment tools to measure a decrease in symptomology and an increase in positive coping strategies throughout the final year of the grant which ends in 2022.

Stop the Silence®

For 21 years, Stop the Silence has provided comprehensive programming locally, nationally, and internationally toward the prevention and mitigation of CSA and ACEs through outreach, education, training, connecting the public to service providers through direct and electronic means, and policy development and reform to effect broad societal change. As of January 1, 2021, Stop the Silence® has officially become a department of IVAT with Dr. Pine as the Director.

Stop the Silence®: A Department of the Institute on Violence, Abuse and Trauma is committed to prevention, treatment, and mitigation of Child Sexual Abuse (CSA), other Adverse Childhood Experiences (ACEs), and related interpersonal trauma. We provide help and resources through comprehensive programming with awareness, education/outreach, training, policy development and reform. We work to address the relationships between childhood trauma and the broader issues of overall family and community violence, and violence within and between communities.

In 2021, the Ho'omaluhia Advisory Council, which consists of 37 representatives from various state agencies in Hawai`i and local nonprofit agencies, held quarterly meetings to review and assess the most effective ways to meet the needs of those on the islands with respect to integration of services and training. Representatives from the Department of Health, Department of Human Services, and the Department of Education among others continue the ongoing work related to issues of homelessness and evaluation of mental health services for people with trauma histories. Additional priority areas consisted of suicide prevention training, social-emotional learning, anti-bullying education, racial equity, trauma informed care education, and sexual violence prevention.


PROGRAM EVALUATION: KAHAUIKI VILLAGE

Kahauiki Village (KV) is a unique project from The Institute for Human Services (IHS) which hopes to build family resilience by growing a neighborhood culture that encourages more positive community experiences. Ho`omaluhia has partnered with IHS to design and implement a program evaluation for KV where families and children share feedback to continuously improve client services and ensure they meet the needs of the community members. Dr. Robert Geffner, IVAT, and Dr. Lori Daniels, Hawai`i Pacific University (HPU), have been working toward formulating the process of analyzing the outcomes, short-term, mediumterm, and long-term impacts for residents at various levels. The logic model provided by HIS and senior staff of KV have quided this process.

In November, 2021, the report on work accomplished in the first year was completed which establishes the methods of measurement and analysis, as well as informing Phase II that will encompass more streamlined data gathering and findings during 2021-2022.

IVAT maintains several research databases that add to the publication and dissemination of literature in a number of topic areas. Our databases are comprised from data collected through the forensic work that the PCFS team has conducted over several decades, as well as from other national practitioners and agencies who have allowed us to store and use their data for research purposes. Dr. Geffner supervises a number of doctorate students as part of his role as Distinguished Research Professor at Alliant International University, and in that capacity works with the students in identifying research topics and questions to be answered using the databases housed at IVAT.

Public Policy & Engagement focuses on the coordination of educational efforts regarding the impact of public policy on individuals and communities, maximizing public policy efforts through public engagement, and developing evidence-based policy perspectives that target the reduction and elimination of interpersonal violence (IPV) and abuse across the lifespan.

Training & Mentoring is dedicated to using educational initiatives to end violence and addresses training and mentoring needs in various professions, including the development of curriculum and other types of educational initiatives.

Action Team 3

Practice links research with policy and best practices to implement trauma-informed care, reducing the impact of previous trauma and breaking the cycle that perpetuates violence across the lifespan.

Action Team 4

Research & Dissemination encourages useful research to further our understanding of the etiology, prevention, and treatment of IPV, and aims to reduce the effects of IPV by disseminating important findings to practitioners and policy makers, promoting the translation of research into practice.

Action Team 5

Global Peace collaborates with allies internationally engaged in parallel efforts to address violence, focusing on initiatives that provide analysis, education, and resources to those working for peace.


